

KRUŽNA PUTOVANJA STRANIH BRODOVA U REPUBLICI HRVATSKOJ u razdoblju od siječnja do prosinca 2021.

FOREIGN VESSELS ON CRUISE IN THE REPUBLIC OF CROATIA January – December 2021

Ukupno ostvareno 208 kružnih putovanja stranih brodova

U razdoblju od siječnja do prosinca 2021. u hrvatske morske luke uplovilo je 36 stranih brodova za kružna putovanja s ostvarenih 208 kružnih putovanja. Na tim brodovima bile su 194 tisuće putnika, koji su u Hrvatskoj boravili 568 dana.

Strani brodovi za kružna putovanja doplovili su pod zastavama 11 zemalja. Najveći broj putovanja strani brodovi za kružna putovanja ostvarili su pod zastavom Paname, i to 68 putovanja, što je 32,7% od ukupno ostvarenih putovanja u 2021. Slijede kružna putovanja ostvarena pod zastavama Malte (32 putovanja) te Bahama (29 putovanja).

Od ukupno 208 kružnih putovanja, najviše ih je ostvareno u Dubrovačko-neretvanskoj (62,5%) i Splitsko-dalmatinskoj županiji (27,4%), što je ukupno 89,9%. Preostalih 10,1% putovanja ostvareno je u sljedećim županijama: Zadarskoj (4,3%), Primorsko-goranskoj i Istarskoj (obje po 2,4%) te Šibensko-kninskoj (1,0%).

Najposjećenija luka Dubrovnik

Najviše posjeta stranih brodova za kružna putovanja imala je luka Dubrovnik (160 posjeta), slijede luke Split (105 posjeta), Korčula (57 posjeta), Šibenik (43 posjeta) te Hvar (41 posjet).

Porast putovanja i putnika na stranim brodovima za kružna putovanja u odnosu na 2020., ali pad u odnosu na 2019.

U razdoblju od siječnja do prosinca 2021. broj putovanja stranih brodova za kružna putovanja veći je za 182 putovanja, a ukupan broj dana boravka brodova veći je za 444 dana u odnosu na isto razdoblje 2020.

Broj putnika na stranim brodovima za kružna putovanja u 2021. veći je za 190 tisuća u odnosu na 2020., kada su zbog pandemije bolesti COVID-19 bile uvedene strože epidemiološke mjere koje su ograničavale broj putnika na tim brodovima.

U odnosu na 2019., broj putovanja stranih brodova za kružna putovanja manji je za 71,3%, broj dana boravka brodova manji je za 61,3%, dok je broj putnika na tim brodovima manji za 82,7%.

A total of 208 journeys of foreign vessels on cruise realised

In the period from January to December 2021, there were 36 foreign vessels on cruise that arrived in Croatian seaports, which realised 208 journeys. There were 194 thousand passengers on board who stayed for 568 days in Croatia.

Foreign vessels on cruise sailed under the flags of 11 countries. The largest number of journeys of foreign vessels on cruise was realised under the flag of Panama, 68 journeys, which was 32.7% of the total journeys realised in 2021. They were followed by journeys under the flags of Malta (32 journeys) and Bahamas (29 journeys).

Out of the total of 208 journeys of foreign vessels on cruise, the majority was realised in the County of Dubrovnik-Neretva (62.5%) and the County of Split-Dalmatia (27.4%), which made up the total of 89.9%. The remaining 10.1% of journeys were realised in the following counties: Zadar (4.3%), Primorje-Gorski kotar and Istria (2.4% each) and Šibenik-Knin (1.0%).

The most visited seaport of Dubrovnik

The majority of visits of foreign vessels on cruise were realised in the seaport of Dubrovnik (160 visits), followed by the seaports of Split (105 visits), Korčula (57 visits), Šibenik (43 visits) and Hvar (41 visits).

Increase in the number of journeys and passengers of foreign vessels on cruise compared to 2020, but a decrease compared to 2019

In the period from January to December 2021, the number of journeys of foreign vessels on cruise increased by 182 journeys and the total number of sojourns by 444 days, as compared to the same period of 2020.

The number of passengers on board foreign vessels on cruise in 2021 increased by 190 thousand compared to 2020, when, due to the COVID-19 pandemic, stricter epidemiological measures were introduced to limit the number of passengers on those vessels.

Compared to 2019, the number of journeys of foreign vessels on cruise decreased by 71.3%, the total number of sojourns by 61.3% and the number of passengers on board those vessels by 82.7%.

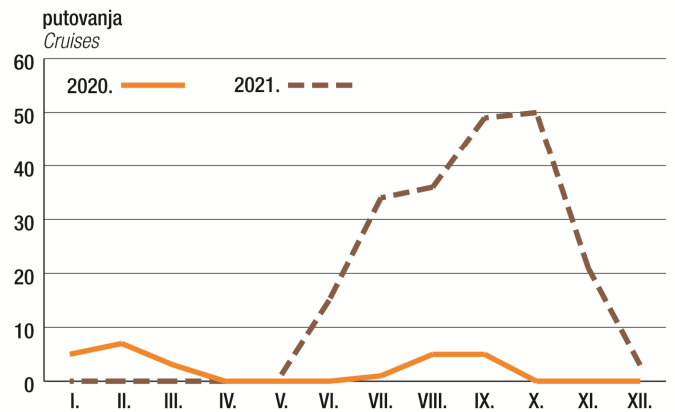

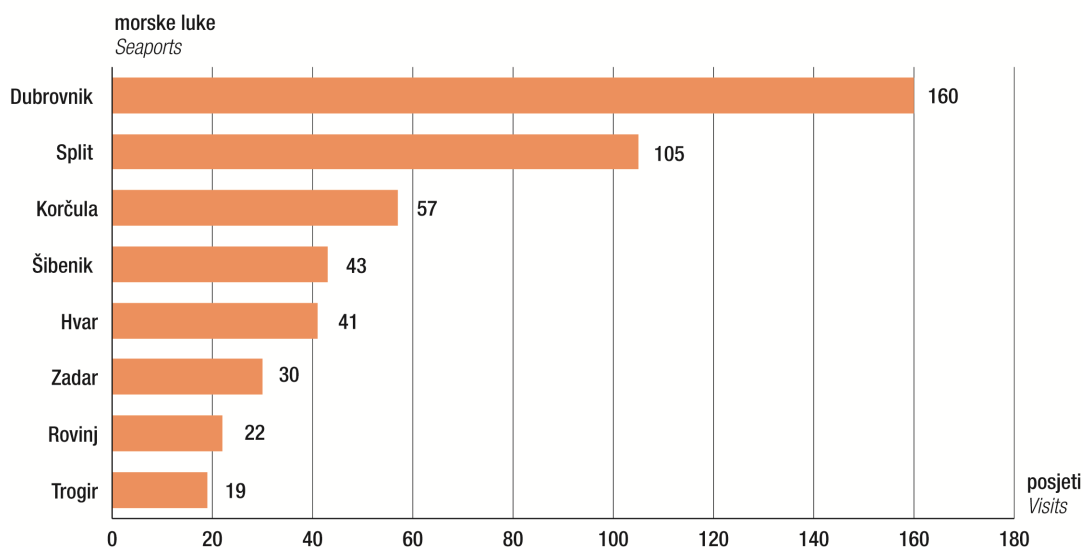

G-2. NAJPOSJEĆENIJE MORSKE LUKE U REPUBLICI HRVATSKOJ U RAZDOBLJU OD SIJEČNJA DO PROSINCA 2021. THE MOST VISITED SEAPORTS IN THE REPUBLIC OF CROATIA, JANUARY – DECEMBER 2021



METODOLOŠKA OBJAŠNENJA

Svrha statističkog istraživanja

Svrha statističkog istraživanja jest praćenje ulazaka stranih brodova za kružna putovanja u teritorijalno more Republike Hrvatske, broja putnika na brodu te dana boravka broda u teritorijalnome moru Republike Hrvatske. Rezultati ovog istraživanja daju pokazatelje potrebne za analizu turizma u Republici Hrvatskoj.

Pravna osnova

Istraživanje se provodi prema Zakonu o službenoj statistici (NN, br. 25/20.).

Izvori i metode prikupljanja podataka

Izvor podataka za statističko istraživanje o kružnim putovanjima stranih brodova u Republici Hrvatskoj jest Hrvatski integrirani pomorski informacijski sustav (CIMIS). Državni zavod za statistiku preuzima dio baze podataka od Ministarstva mora, prometa i infrastrukture te je dalje statistički obrađuje.

U sustav CIMIS, putem ovlaštenih pomorskih agenata i brodara, brodovi dostavljaju, među ostalim podacima, i podatke o brodu, putovanju i putnicima. Točnost i cjelovitost podataka u službenom postupku prijave verificira lučka kapetanija.

Obuhvat i usporedivost

Jedinica promatranja za ovo istraživanje jest strani brod koji je na turističkome kružnom putovanju i ulazi u teritorijalno more Republike Hrvatske.

U tablicama 1., 2. i 3. podaci o kružnim putovanjima stranih brodova obuhvaćaju **samo morske luke prvog ulaska** stranog broda za kružno putovanje u teritorijalno more Republike Hrvatske.

U grafikonu G-2. podaci o posjetima stranih brodova na kružnim putovanjima obuhvaćaju **sve morske luke** koje su ti brodovi posjetili za vrijeme boravka u teritorijalnome moru Republike Hrvatske. Posjeti u morskim lukama prikazuju se po statističkim lukama koje se sastoje od jedne ili više luka pod nadzorom lučke ispostave koja može registrirati kretanja brodova, putnika i tereta.

NOTES ON METHODOLOGY

The purpose of the statistical survey

The statistical survey is aimed at monitoring the entries of foreign vessels on cruise in the internal sea waters of the Republic of Croatia, the number of passengers aboard and the days in which a ship stays in the internal sea waters of the Republic of Croatia. The results of this survey provide indicators used in the analysis of tourism in the Republic of Croatia.

Legal basis

The survey is carried out on the basis of the Official Statistics Act (NN, No. 25/20.).

Sources and methods of data collection

The data source for the statistical survey on cruises of foreign vessels in the Republic of Croatia is the Croatian Integrated Maritime Information System (CIMIS). The Croatian Bureau of Statistics takes over a part of the database from the Ministry of Sea, Transport and Infrastructure, after which it performs further processing.

Among other data, ships submit information on the ship, journey and passengers to this system through authorised maritime agents and shippers. The accuracy and completeness of the data in the official proceedings of registration is verified by the harbour master's offices.

Coverage and comparability

Observation unit for this survey is a foreign vessel on a tourist cruise that enters the internal sea waters of the Republic of Croatia.

In the tables 1., 2. and 3., the data on foreign vessels on cruise include only **seaports of the first entry** of the foreign vessel on cruise into the internal sea waters of the Republic of Croatia.

In the Graph G-2., the data on visits of foreign vessels on cruise include **all seaports** visited by those vessels during their stay in the internal sea waters of the Republic of Croatia. Visits in seaports are presented by statistical seaports consisting of one or more ports, normally controlled by harbour master's branch offices able to record ship and cargo movements.

Definicije

Brod za kružna putovanja jest putnički brod čija namjena nije prijevoz osoba od jedne luke do druge luke odredišta, nego je namijenjen za uživanje u putovanju i sadržajima na brodu (luksuznom ugođaju, avanturama, obrazovanju, kulturi, zabavi, sportskim aktivnostima, wellnesu ili rekreaciji). Opremljen je za višednevni boravak putnika i mora pružati usluge prehrane, pića i napitaka te usluge smještaja. Brod za kružna putovanja pristaje na svojem putu u lukama koje su zanimljive turističke destinacije.

Putovanje je ulazak stranog broda za kružna putovanja u prvu luku teritorijalnog mora Republike Hrvatske.

Posjet je ulazak stranog broda za kružna putovanja u svaku luku teritorijalnog mora Republike Hrvatske.

Putnici na brodu jesu osobe koje su doputovale brodom, bez obzira na dob. Članovi posade na brodu ne smatraju se putnicima.

Dani boravka broda čine ukupan broj dana koje brod provede u teritorijalnome moru Republike Hrvatske.

Zastava broda predstavlja državu u kojoj je brod registriran, odnosno upisan u upisnik brodova te je u skladu s njezinim zakonodavstvom.

Statistička luka sastoji se od jedne ili više luka pod nadzorom lučke ispostave koja može registrirati kretanja brodova, putnika i tereta.

Definitions

Foreign vessel on cruise means a passenger ship intended rather to provide passengers with a pleasure of a journey and facilities for entertainment aboard (luxurious atmosphere, adventures, education, culture, entertainment, sports activities, wellness or recreation) than the transport of persons from one seaport to another. It is equipped for a multi-day stay of passengers aboard and must provide food, drinks and accommodation services. On its journey, a foreign vessel on cruise stops in seaports of several interesting destinations.

A journey is an entry of a foreign vessel on cruise into the first seaport of the internal sea waters of the Republic of Croatia.

Visit is an entry of a foreign vessel on cruise into every seaport of the internal sea waters of the Republic of Croatia

Passengers on board are any persons who arrived by ship irrespective of age, providing that he/she is not a crew member.

Sojourns represent a total number of days a ship spends in the internal sea waters of the Republic of Croatia.

Flag of vessel represents the country in which a ship is registered, that is, entered into the ship registry and is bound by its laws.

Statistical seaport consists of one or more ports, normally controlled by harbour master's branch offices able to record ship and cargo movements.
