

KRUŽNA PUTOVANJA STRANIH BRODOVA U REPUBLICI HRVATSKOJ u razdoblju od siječnja do lipnja 2020.

FOREIGN VESSELS ON CRUISE IN THE REPUBLIC OF CROATIA January – June 2020

Veliki pad broja putovanja stranih brodova za kružna putovanja na hrvatskom Jadranu zbog pandemije bolesti COVID-19

Zbog pandemije bolesti COVID-19 uvedene su mjere zabrane uplovljavanja brodova na međunarodnim kružnim putovanjima, što je izravno utjecalo na smanjenje broja stranih brodova za kružna putovanja u hrvatskim morskim lukama u ožujku 2020. i na njihov nedolazak u travnju, svibnju i lipnju 2020. U razdoblju od siječnja do lipnja 2020. ostvaren je pad broja stranih brodova za kružna putovanja u hrvatskim morskim lukama za 88,9% u odnosu na isto razdoblje 2019.

U prvih šest mjeseci 2020. strani brodovi za kružna putovanja ostvarili su pad broja putovanja za 94,5% i broja dana boravka na hrvatskom Jadranu za 91,5% u odnosu na isto razdoblje 2019. Broj putnika na tim brodovima u odnosu na isto razdoblje 2019. manji je za 99,1%.

U prvih šest mjeseci 2020. ostvareno 15 kružnih putovanja stranih brodova

U razdoblju od siječnja do lipnja 2020. u hrvatske morske luke uplovilo je šest stranih brodova za kružna putovanja, koji su ostvarili 15 kružnih putovanja. Na tim brodovima bilo je 3 737 putnika, koji su u Hrvatskoj boravili 47 dana.

Dvanaest putovanja ostvarili su brodovi pod zastavom Malte, dok je najveći broj putnika pristigao brodovima pod zastavom Italije (2 690 putnika).

Od ukupno 15 kružnih putovanja, 73,3% putovanja ostvareno je u Dubrovačko-neretvanskoj županiji, dok je ostalih 26,7% putovanja ostvareno u Istarskoj županiji.

A major decrease in the number of journeys of foreign vessels on cruise in the Croatian Adriatic due to the COVID-19 pandemic

Due to the COVID-19 pandemic, measures were introduced to prohibit the entry of ships on international cruises, which had a direct impact on a decrease in the number of foreign vessels on cruise in Croatian seaports in March 2020 and on their absence in April, May and June 2020. In the period from January to June 2020, the number of foreign vessels on cruise in Croatian seaports was 88.9% lower, as compared to the same period of 2019.

In the first six months of 2020, foreign vessels on cruise realised a decrease in the number of journeys of 94.5% and in the number of sojourns in the Croatian Adriatic of 91.5%, as compared to the same period of 2019. The number of passengers on board these vessels decreased by 99.1%, as compared to the same period of 2019.

In the first six months of 2020, a total of 15 journeys of foreign vessels on cruise were realised

In the period from January to June 2020, six foreign vessels on cruise arrived in Croatian seaports, which realised 15 journeys. There were 3 737 passengers on board these vessels, who stayed for 47 days in Croatia.

Twelve cruises was realised by vessels under the flag of Malta, while the highest number of passengers on board the arrived vessels were under the flag of Italy (2 690 passengers).

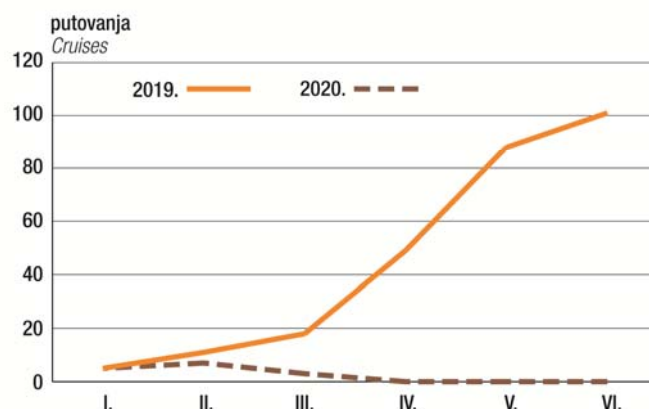
Out of the total of 15 journeys of foreign vessels on cruise, 73.3% was realised in the County of Dubrovnik-Neretva while the remaining 26.7% of journeys were realised in the County of Istria.

METODOLOŠKA OBJAŠNJENJA

Svrha statističkog istraživanja

Svrha statističkog istraživanja jest praćenje ulazaka stranih brodova za kružna putovanja u teritorijalno more Republike Hrvatske, broja putnika na brodu te dana boravka broda u teritorijalnome moru Republike Hrvatske. Rezultati ovog istraživanja daju pokazatelje potrebne za analizu turizma u Republici Hrvatskoj.

Pravna osnova

Istraživanje se provodi prema Zakonu o službenoj statistici (NN, br. 25/20.) i Godišnjemu provedbenom planu statističkih aktivnosti Republike Hrvatske 2020. godine (NN, br. 12/20.).

Izvori i metode prikupljanja podataka

Izvor podataka za statističko istraživanje o kružnim putovanjima stranih brodova u Republici Hrvatskoj jest Hrvatski integrirani pomorski informacijski sustav (CIMIS). Državni zavod za statistiku preuzima dio baze podataka od Ministarstva mora, prometa i infrastrukture te je dalje statistički obrađuje.

U sustav CIMIS, putem ovlaštenih pomorskih agenata i brodara, brodovi dostavljaju, među ostalim podacima, i podatke o brodu, putovanju i putnicima. Točnost i cjelovitost podataka u službenom postupku prijave verificira lučka kapetanija.

NOTES ON METHODOLOGY

The purpose of the statistical survey

The statistical survey is aimed at monitoring the entries of foreign vessels on cruise in the internal sea waters of the Republic of Croatia, the number of passengers aboard and the days in which a ship stays in the internal sea waters of the Republic of Croatia. The results of this survey provide indicators used in the analysis of tourism in the Republic of Croatia.

Legal basis

The survey is carried out on the basis of the Official Statistics Act (NN, No. 25/20) and the Annual Implementation Plan of Statistical Activities of the Republic of Croatia 2020 (NN, No. 12/20).

Sources and methods of data collection

The data source for the statistical survey on cruises of foreign vessels in the Republic of Croatia is the Croatian Integrated Maritime Information System (CIMIS). The Croatian Bureau of Statistics takes over a part of the database from the Ministry of Sea, Transport and Infrastructure, after which it performs further processing.

Among other data, ships submit information on the ship, journey and passengers to this system through authorised maritime agents and shippers. The accuracy and completeness of the data in the official proceedings of registration is verified by the harbour master's offices.

Obuhvat i usporedivost

Jedinica promatranja za ovo istraživanje jest strani brod koji je na turističkome kružnom putovanju i ulazi u teritorijalno more Republike Hrvatske.

Podaci o kružnim putovanjima stranih brodova obuhvaćaju samo morske luke prvog ulaska stranog broda za kružno putovanje u teritorijalno more Republike Hrvatske (tablica 1., tablica 2. i tablica 3.).

Definicije

Brod za kružna putovanja jest putnički brod čija namjena nije prijevoz osoba od jedne luke do druge luke odredišta, nego je namijenjen za uživanje u putovanju i sadržajima na brodu (luksuznom ugođaju, avanturama, obrazovanju, kulturi, zabavi, sportskim aktivnostima, wellnesu ili rekreaciji). Opremljen je za višednevni boravak putnika i mora pružati usluge prehrane, pića i napitaka te usluge smještaja. Brod za kružna putovanja pristaje na svojem putu u lukama koje su zanimljive turističke destinacije.

Putovanje je ulazak stranog broda za kružna putovanja u prvu luku teritorijalnog mora Republike Hrvatske.

Putnici na brodu jesu osobe koje su doputovale brodom, bez obzira na dob. Članovi posade na brodu ne smatraju se putnicima.

Dani boravka broda čine ukupan broj dana koje brod provede u teritorijalnome moru Republike Hrvatske.

Zastava broda predstavlja državu u kojoj je brod registriran, odnosno upisan u upisnik brodova te je u skladu s njezinim zakonodavstvom.

Coverage and comparability

Observation unit for this survey is a foreign vessel on a tourist cruise that enters the internal sea waters of the Republic of Croatia.

Data on foreign vessels on cruise cover only seaports of the first entry of a foreign vessel into the internal sea waters of the Republic of Croatia (table 1, table 2 and table 3).

Definitions

Foreign vessel on cruise means a passenger ship intended rather to provide passengers with a pleasure of a journey and facilities for entertainment aboard (luxurious atmosphere, adventures, education, culture, entertainment, sports activities, wellness or recreation) than the transport of persons from one seaport to another. It is equipped for a multi-day stay of passengers aboard and must provide food, drinks and accommodation services. On its journey, a foreign vessel on cruise stops in seaports of several interesting destinations.

A journey is an entry of a foreign vessel on cruise into the first seaport of the internal sea waters of the Republic of Croatia.

Passengers on board are any persons who arrived by ship irrespective of age, providing that he/she is not a crew member.

Sojourns represent a total number of days a ship spends in the internal sea waters of the Republic of Croatia.

Flag of vessel represents the country in which a ship is registered, that is, entered into the ship registry and is bound by its laws.
